1. Disclaimer

The Hudson Legion Curling Club and its directors, officers, committee members, employees, coaches, Volunteers, officials, participants, agents, sponsors, owners/operators of the facility, and representatives (the "Organization") are not responsible for any injury, property damage, expense, loss of income, damage or loss of any kind suffered by a Participant during or as a result of any program, activity or event of the Organization caused in any manner whatsoever including, but not limited to negligence of the Organization.

2. Description of Risks

I am participating voluntarily in the sport of curling and the activities, events and programs of the Organization. In consideration of my participation in the sport of curling and the programs, activities and events of the Organization, I hereby acknowledge that I am aware of the risks, dangers, and hazards associated with or related to the sport of curling and the programs, activities, and events of the Organization. I am aware that there are risks and possible injuries can result from the activities of the Club and the game of curling.

3. Release of Liability

In consideration of the Organization allowing me to participate, I agree:

- a. That to the best of my knowledge I am fit to participate in the sport of curling and in the activities, events and programs of the Organization (**Important: if you have concerns please speak to your personal physician**)
- b. To waive any and all claims that I may have now and in the future against the Organization
- c. To freely accept and fully assume all such risks and possibility of personal injury, death, property damage, expense and related loss including loss of income, resulting from my participation in the activities, events and programs of the Organization;
- d. To assume all risks arising out of, associated with or related to my participation;
- e. To be solely responsible for any injury, loss or damage that I might sustain while participating; and,
- f. To forever release, discharge, save harmless and indemnify the Organization from any and all liability for any and all claims, demands, actions, damages (including direct, indirect, incidental, special and/or consequential), losses (economic and non-economic), judgments, executions and costs (including legal fees) which I may have or may in the future, that might arise out of my participation in the activities, events and programs of the Organization or traveling to or from, due to any cause whatsoever, even though such risks, injuries, loss, damage, claims, demands, actions, or costs may have been caused by any manner whatsoever, including but not limited to negligence, omissions, carelessness, breach of contract, or breach of any duty of care of the Organization.
